Employment as an apprentice in the power line apprenticeship training program requires agreement to sign an apprenticeship agreement.

The apprenticeship will require periodic written examinations and review

to determine progress and continued employment. Must be familiar with RUS construction specifications

Must become knowledgeable of Tri-County EMC service rules and

regulations, procedures, policies

Working knowledge of the National Electric Code and National Safety code Must have a valid commercial license, as specified by the Cooperative,

within nine months of employment or on the hire at the discretion of management. This will be determined based on job related needs only

Must meet D. O. T. Certification requirements Certified by the American Red Cross in CPR

Must be able to communicate effectively with the public and employees of

the EMC

Must not have any physical impairment or manual dexterity, hearing, speech, or sight that

will affect job capability

Preferred: Training and successful completion of Northwest Lineman College apprenticeship

program or other approved apprenticeship program

Experience with an electric cooperative

PHYSICAL DEMANDS: Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

Physical work-Examples: 60% walking and standing, 20% sitting, 10% Climbing Poles (apprenticeship training) 10% Lifting (maximum 100 pounds unassisted), pushing and pulling. Operation of heavy equipment, machinery, or vehicles. Exposure to hazardous conditions (high voltage lines and powered equipment)

- D. Assists line Technicians in the performance of their duties
- E. Maintain all equipment in operable, clean, and safe conditions
- F. Must meet all requirements and standards of the Cooperative's First Class Line Technician training program.
- G. Safety Responsible for the knowledge of an abiding by the Board of Directors approves by Georgia EMC Safety Manual and EMC Operations Manual.
- H. Immediately report all accidents or property loss to supervisor
- I. Perform all other duties and tasks as assigned
